Minutes. Moved that the minutes of the 2019 AGM, as circulated be confirmed as a true and correct record of proceedings.

Roll over of Officers and Delegates. Moved that they remain the same until the 2021 AGM. B. Hickey/B. O'Dea. Carried.

Notice of Motion. That the amended Constitution be adopted with a small typo in clause 15.2 corrected.

B. O'Dea congratulated Allan and Sally on the work they had done to complete the revised Constitution. The Chair agreed but cautioned that there would need to be more changes next year to accommodate the changes related to the new Incorporated Societies Act.

Moved that S. Blyth replace J. Cowan as a signatory for the BNZ account.

Reports. Members Council by B. Hickey. The Council is to meet with the NZTR Board four time each year. The first of them was in the South Island. Although the report of that meeting was not available Bernard gave a summary of the meeting. The report will be circulated. Discussion and comments followed.

General Business.

Wanganui was concerned that the weights had not gone back to pre Covid levels.

B. O'Dea was concerned that the nominations for Saturday races closed on Tuesday, acceptances closed on Wednesday and jockeys named on Thursday. However, as horses were being accepted in several races the rule regarding the jockeys was not being enforced by NZTR. He considered that any horse that did not have jockey by Thursday should be scratched. Discussion followed with a split decision. Chairman would raise as a general item at monthly NZTR Stakeholder conference call

Jim reported that a Member had suggested that the Federation should recognise the effort made by the previous Racing Minister to get the new Racing Act passed. It was agreed that an article would go in the next bulletin.
